CSD 694 - Advanced Clinical Practicum - is currently offered in the degree plan as a repeatable, variable credit-hour course. It is taken 2 - 3 times. The class accompanies the clinical practice rotations in year 2 of the graduate program, and provides information, hours-tracking, and problem-solving support to students as they complete their internships. We are applying to modify the variable credit-hour options (currently 1-2 hours) to 1- 3 hours (3 hours had previously been approved for this course, as reflected in the current catalog course description). (Note: The degree plan in the catalog lists that the course is offered as 1-2 hours variable credit; the course description lists it as only available for 3 hours. We desire to have consistent information communicated across the catalog. We want the option to offer CSD 694 for 1, 2 or 3 hours course credit to provide program flexibility for special situations such as extra internships (remediations) or internships of increased length. This change will not increase the length of the degree plan for the MS-SLP degree, but will be utilized as an option in situations as noted above.

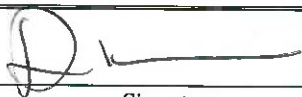
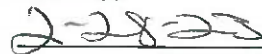
¹ When an academic unit does not have a council, the UGEC and/or UUAC will serve as its academic council, depending on the nature of the issue.

Departments may request exceptions to the first three criteria.

³ For undergraduate majors, a minimum of 30 hours is required. These programs must have a minimum of 6 elective hours, unless the requirements of external accrediting bodies make it impossible.
