Degree Plan(s): Master of Science in Occupational Therapy (MSOT) and Occupational Therapy Doctorate (OTD)

This course currently occurs during the first Level 2 Fieldwork Rotation, taught online in the Spring Semester. The course no longer meets any required accreditation standards and topics are sufficiently covered throughout curriculum and in concurrent fieldwork coursework. Additionally with new accreditation standards, the two credit hours will be better utilized in other areas in the curriculum. Proposing to close course OCCT 703 with intent to add 2 credit hours earlier in the curriculum in a more relevant content area (Spring of 1st year vs. Spring of 2nd year). Overall credit hours for program(s) will not change. Dropping this class does not affect timing of graduation or offer any other changes to the students matriculation or overall learning outcomes.

Master's programs must include a minimum of 30 hours, and doctoral programs must include a minimum of 30 hours beyond the master's.

⁴ When a department/school or dean proposes closing a program, approval routing follows the typical process beginning with the department/school. An administrative proposal by the provost or senior vice president for academic affairs would follow the "provost-proposed" routing on the chart.
