Increase in cohort size and accreditation changes have prompted curricular changes in the OTD program. Research related courses have been shifted and this course is no longer needed in the first spring semester. Closure of this course will not alter the overall degree requirements and credit hours as the proposed new course mentioned above will now suffice the requirements for scholarly activity in the OTD program and replace the credit hours.

³ For undergraduate majors, a minimum of 30 hours is required. These programs must have a minimum of 6 elective hours, unless the requirements of external accrediting bodies make it impossible. Master's programs must include a minimum of 30 hours, and doctoral programs must include a minimum of 30 hours beyond the master's.

⁴ When a department/school or dean proposes closing a program, approval routing follows the typical process beginning with the department/school. An administrative proposal by the provost or senior vice president for academic affairs would follow the "provost-proposed" routing on the chart.
