- Master of Divinity (MDiv)
- Master of Divinity, Missions (MDiv Miss)
- Master of Arts in Christian Ministry (MACM)
- Master of Arts in Global Service (MAGS)

Note: Because the form provided from the Provost's office gives the option to include multiple degree plans on a single form, I am filing one form for all degree plans rather than submitting a form for each. The form itself, and the nature of the curricular change, allow for this.

Proposed Change:

Remove the Senior Review as a graduation Requirement for MDiv, MDiv Missions, MACM, and MAGS degrees within the Graduate School of Theology.

Rationale for Change:

Maintaining the Senior Review as a separate graduation requirement is a redundancy within GST degree plans and wider systems. Students are required to complete BIBM 678 Senior Portfolio Review, of which the Senior Review is one piece. Those students who do not successfully complete the Senior Review receive a grade of "NC" for BIBM 678, and must retake the course and Senior Review before they can graduate. Thus, BIBM 678 provides sufficient mechanisms to ensure a completed Senior Review and makes a separate graduation requirement unnecessary. This change to the degree plans listed above reflects existing GST practice and better aligns GST and University systems to it.

² Any change to a cross-listed course requires the signature of both department chairs or program directors overseeing the course to ensure that the courses stay in sync. This includes courses taught at other campuses (e.g. BIBL 101 and BIBO 101).

³ For undergraduate majors, a minimum of 30 hours is required. These programs must have a minimum of 6 elective hours, unless the requirements of external accrediting bodies make it impossible. Master's programs must include a minimum of 30 hours, and doctoral programs must include a minimum of 30 hours beyond the master's.

⁴ When a department/school or dean proposes closing a program, approval routing follows the typical process beginning with the department/school. An administrative proposal by the provost or senior vice president for academic affairs would follow the "provost-proposed" routing on the chart.

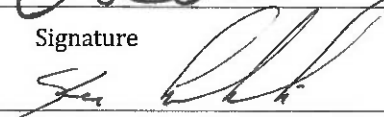
