Course Number: OCCT 724 **Degree Plan(s):** Occupational Therapy Doctorate (OTD)

OTD capstone project development begins in the first semester of the OTD curriculum and continues into this course OCCT 724 Capstone Seminar 4. Currently the students are graded on a traditional letter grade scale. This proposal is to move the capstone project development courses to Credit/No Credit grading. The courses OTD I-V are sequential and credit is based on the completion of milestones each semester. Assigning a letter grade is difficult as each project is variable and the objective is not to attain a certain grade but rather to meet expectations set forth by the program through these milestones. At this time OTD V (the final course in this sequence) is a CR/NC course.

Students would receive Credit for this course OCCT 724 through meeting the following objectives which are currently the course outcomes:

1. Capstone Document Chapters 1-3, inclusive of goals and timeline, completed and approved by capstone coordinator and faculty mentor.
2. Updated experience plan and goals completed and approved by capstone coordinator and faculty mentor.

³ For undergraduate majors, a minimum of 30 hours is required. These programs must have a minimum of 6 elective hours, unless the requirements of external accrediting bodies make it impossible. Master's programs must include a minimum of 30 hours, and doctoral programs must include a minimum of 30 hours beyond the master's.

⁴ When a department/school or dean proposes closing a program, approval routing follows the typical process beginning with the department/school. An administrative proposal by the provost or senior vice president for academic affairs would follow the "provost-proposed" routing on the chart.
