We created a new course, BMFT 612 Couples Therapy II, to replace BMFT 651 Sexual Therapy, based on student feedback and to replace duplicative content with missing content. Couples Therapy II includes unique content from Sexual Therapy, plus additional content not covered elsewhere in the program. Making this change does not affect our accreditation status or the ability of our students to obtain licensure, since the content of both classes is related to working with couples. Couples Therapy II will continue to be an option for PSYC and SOCW students who may need a course related to working with couples.

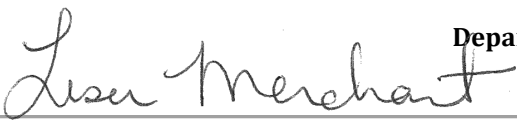

³ For undergraduate majors, a minimum of 30 hours is required. These programs must have a minimum of 6 elective hours, unless the requirements of external accrediting bodies make it impossible. Master's programs must include a minimum of 30 hours, and doctoral programs must include a minimum of 30 hours beyond the master's.

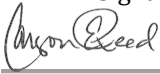
