Comments -



- There were no expectations established for the course. Our first test was cancelled so we were not able to get a feel for how the course would go. There were three different online platforms that we were expected to keep up with, all three platforms had their own assignments due at different times. One of the online platforms was a course taught by a complete third party which is absolutely free to any user. There were also no system requirements. At the end of the semester I was unable to complete a vital part of course. The class was held in a computer lab but more than half the class had to use their own computers because there weren't enough computers in the lab. If I had known in advance that I would need Access and more RAM I could have prepared for it, but since there was no prior warning, I was left unable to complete the assignment. Many classes consisted of both the instructor and the students attempting to open files. It appeared the professor was unprepared for class. As a Management major with no prior technology courses I felt behind and was unable to complete assignments due to my unfamiliarity. I was excited to take this course because SAP is a valuable skill for many occupations. Unfortunately I do not feel that I have learned enough about SAP to list it as a skill on my resume. I feel that I wasted my time and my tuition dollars on this course.
- I feel like the class was organized in the beginning, but slowly became more chaotic towards the end. For example, on WileyPlus, due dates weren't established until the 3rd week of school and changed towards the end of the class. I was not sure what to do and when it was due. We also took an online course in parallel to this course. I understand that it was a free learning opportunity, but due to the content being outside of the scope of the class, a majority of us had difficulty completing the online course.

- She obviously wants us to learn. She shows that she cares about us by being constantly available to answer questions and fulfill

 theme of the course (operations management). This has made it hard to learn and perform well.

This is my second time to take the class from 3 semesters ago and it has not changed one single bit. I felt the same then as I do now. - Although she is an incredibly nice and kind woman, her ability to comprehend relevant content as it pertained to the subject being
 taught was very low. We were constantly tested on material that was never covered nor mentioned during class time. We were
 briefly introduced to online systems, but the retention of the system was quickly forgotten because Dr. Burton had no way of truly
 gaging our comprehension of the system in a measurable way. There is no textbook for the class, so the students were generally
 confused about the direction and concrete material being covered in the course.
- Dr. Burton is an extremely nice teacher who genuinely cares about her students and seeing that they do well. She constantly reminds us of ethical business practices and wants us to be sustainable in the future. She is scattered and it is sometimes confusing to follow what is going on in class, but she is always updating Canvas and has everything posted on there which makes it easy to keep up with what is going on in the class. This class is more technical than most management classes, which is why the students in the class don't have the best attitudes all of the time since they don't understand technology that much, but she does a great job at trying to help us understand and guiding us to find the solutions.
- Dr. Burton is a very nice lady, but a terrible teacher. She does not explain anything clearly and expects students to figure out material alone. One example is on the last test she told us, "Just know the over-arching ideas, no specifics." The majority of the points on the test were open ended definitions of terms that we had to write in ourselves. If that is not specifics, I do not know what is. No matter what I say, she will not get fired. She is one of the teachers who thanks tenure each semester to keep her job. When I met with my advisor to sign up for classes, she even admitted the class isn't bad, it was just the teacher who was bad. Please, for the sake of all future students, fire Dr. Burton regardless of tenure.
- Honestly, I love her as a person, but I feel she did not teach us the material in a way to where we actually understood the material.

- Dr. Burton is great at showing her students that she genuinely cares for them. She also is clearly passionate about the subject matter. However, she is often unclear in her explanations. In addition, she is known to be biased in her grading. It can be somewhat difficult for even hard working, motivated students to succeed in Operations Management because of this.
- I loved her enthusiasm but I found it difficult to follow her teacher habits

- Dr. Burton did push us with assignments to monitor progress in between tests. However, she was often unclear in her expectations and I occasionally found myself leaving class more confused than I came. She often struggled with "dancing around the question," rather than being able to give us a straight answer, which also hindered the class' clarity. It was good that she stayed on top of the syllabus, updating it as things changed; however, sometimes I feel like we would come into class and the syllabus would be all we would talk about, rather than the actual learning material. My reaction to this class would've been more positive had I not felt so confused and left in the dark about actual expectations beyond what was obvious on the surface. Any one of us could have easily read what was on the syllabus in front of us; I wanted to learn more about the actual concepts of Operations Management (especially what we would be tested on). With all of the hands-on activities that we have, I feel like it would be beneficial to have much more applicable explanations. Rather than just handing us a job aid for the ERP Sim, an actual walkthrough of a few minutes worth of the simulation would help clear up understanding issues. Overall, more clear explanations of what is expected throughout all aspects of the class would be my biggest suggestion.
- She was never direct in anything to stated or when answering questions. She did not give us good guidelines for what she expected and was vague in everything she said. She was bad about communicating grades and did not seek to help students when they did not understand her method or subject matter. She made us do almost everything in groups that we did not choose and based many points on peer evaluations. We did various simulations that we did not fully understand and the information we were learning was not is application with what we were expected to reproduce in the simulations. If there were any other teacher offering this course I would have dropped this class in a heartbeat.
- Orneita is a nice lady and a good teacher. She is passionate about the subject. I think that she could improve on explaining things to the class better. Some class periods we spent way too much time talking about the timeline of the week and didn't get to the real content of the class. I was frustrated when it came to working with SAP. The instructions and simulation were not clear cut like the powerpoint and instructions given by the teacher. I would like to be able to put some SAP experience on my resume, but I know myself and many others in the class still don't have a good grasp of it. My suggestions for the SAP part of the course is to find a better way to show the class how to use it. Maybe on one of the class periods where it was spent explaining, actually go through the simulation and have better steps. The job aid doesn't show all the functions to complete. As a student that wants to go into project management. I thought taking a class called production and process management would be more of a concentrated class. I found that it is very similar to the Supply Chain and Logistics class. It had very broad concepts and I don't feel like I gained as much knowledge about the area I'm going into as I would have liked. I guess my main critique is to fill the class period with more content then explaining what will be on the test or timeline of what we are doing that week. The SAP is great experience, but it needs to be better explained.
- Professor Burton, thank you for teaching us ethical applications and how to think of our work from a Christ-serving veiwpoint; thank you also for taking a professional interest in us as students and for encouraging us to learn by our own means. However, most of us had no beginning point on which to learn all that you wanted us to learn the majority of the time, my fellow students and I wished for more direct instruction and a more coherent structure of course material; we wanted to learn in class what we needed to know to be effective at managing operations. I gathered from talking with my classmates that we were "winging it" most of the time on class projects (especially the ERP simulation) because we simply didn't know what to do, and were rushed and stressed. Because of this, we didn't learn how to manage an operation so much as how to simply get by. I know for a fact that students would perform better if we listened in class and applied themselves in learning the material, so a large part of the frustration and confusion with the class can be assigned to us; but we would also perform better if we were directly taught the material instead of where the material was organized on Canvas.
- I love Dr. Burton. In this course, she has challenged me to become a better steward of my gifts and talents and to always work hard and work with strong ethics. Out of all the professors in COBA that I have taken classes with, she is by far the most committed to seeing her students not just succeed in the business world, but more importantly in their relationship with Christ. I admire how she prays before every class and places a strong emphasis on stewardship and good morals in the business environment. She also demonstrates these qualities by being open to students' suggestions, providing feedback quickly, and treating her students like adults. A few suggestions: Dr. Burton is sometimes unclear with guidelines for assignments. I think that some of the less technologically savvy individuals have a hard time understanding projects and assignments. Overall, Dr. Burton could be a little more clear in class and with assignments but I think she is great!
- I feel that Mrs. Burton is a very lady, and truly does want the best for all of her students. That being said i think a lot of class time was waisted because of her rambling about ethics and other things that she had already talked about three classes in a row before. She talks about nothing to much and then we are crammed at the end of class to get the assignments done before time runs out, we then are still tested over the material that is talked about and practiced maybe 25% of the class time. The other 75% of the class time is her rambling. Also the SAP software we installed for the work in this class has made my computer so slow and glitchy. It has made it a challenge to get my computer to work for other classes because of this software. Overall, Burton is a very

nice lady that I believe wants the best for all of her students. But this class she teaches could be summed up in 1 to 2 weeks easily, she is being forced to drag it out over a semester and that is why i believe there are so many bad reviews in the past on this class. Since it should only last 1 to 2 weeks we as the students feel that we do not learn anything from her which results in frustration. If you had to drink one cup of water over the span of the semester, you would get much more out of it if you just sat and drank it all in one sitting, as opposed to sipping it one sip everyday for a few months. Same goes with this class, if it was all taken in a shorter period this class would be much more beneficial.

- The class work assigned constantly throughout this semester was not relevant occasionally towards what we were attempting to learn in class. The tests you gave I had to study hard for in able to receive sub-par grades because of the uncertainty of what I have been learning. I had a difficult time following your train of ideas while teaching and was left confused about larger portions of the material for the course. It was upsetting to see how well certain students succeeded in this class while admitting they knew certain above average grades they received weren't what they should have been while I was sub-par.
- She is a really great teacher and shows a great concern for her students. However she needs to do more step by step instructions for the technology used for this course. She should also do a walkthrough of the technologies used in class. I SAP GGUI isn't easy for everyone, and the game that we play using it has many isses that could have been solved a lot faster if she would have done a walthough of the program. A lot of the students had the same problems with it, so if she would have done a group walkthrough instead of trying to solve the issues individually things would have gone smoother and quicker. Just keep in mind that we may be in the age of technology but there are still MANY people who struggle with using computers, even at the college level. They just don't like admitting it. Walkthoughs would REALLY help those students.
- There was very little that I learned from this class. This class had some very high potential and could've been good, but the professor ultimately ruined it. Ninety percent of the time, the entire class had no idea what was going on. There was a three week period where we talked about aids, ebola, and ISIS which have nothing to do with Operations Management. The week following all of that we were tested on material we hadn't learned. If students are ever going to get anything out of this class, the professor needs to leave.
- Mrs. Burton is a nice person but she lacks in teaching. She's not a very good explainer in which that her assignments are vague. In
 class no one knows what she's talking about. She gives us assignments that has nothing to do with operations mgmt. Ex. She
 gave us an assignment to read ISIS Manifesto and how does that work with Operations Mgmt. It doesn't.... It would make sense if
 the class was BCORE or a religion class. Like I said she's a nice person but has no skills in teaching this course.
- She's a really nice lady. I think she genuinely cares about her students and Jesus. But, the simulation was a waste of time. It wasn't explained very well so no one in the class knew what was going on. If the simulation was explained better and more in depth than I think it would be better. In addition to this, the software messed up our computers. I felt like I had no idea what was going on in the class. It was very unclear what specific things we were learning. There seemed to be no organization. There are also rumors that there is favoritism in the classroom. We were told by classmates that some students grades were bumped up a significant amount if they prayed during class.
- Dr. Burton is a great person and is ahead on some aspects of learning. However, some test material was difficult and I felt like it was not covered or taught well enough. This was a course where studying longer did not or would not improve one's results. In the end, Dr. Burton is a good professor who truly cares that her students learn.
- I think she is a great professor. However, sometimes she is too vague about her assignments and exams.
- Nobody even knew what was going on in this class. We would come to class and spend 25 minutes talking about the assignment
 for tonight or even an assignment a week and a half away. A lot of the assignments seemed like busy work and required students
 to make stuff up.
- I value Orneita Burton as a person and fellow Christian. However, all of the course content was very blurry and unclear to me. I never felt like I was actually learning anything because I was confused most of the time. I didn't even know how to use the simulation that we did in class. I feel that the course could be very interesting and productive if the content was taught thoroughly. I could've gotten an A rather than a B if I understood better.
- I do not feel like I have gained much from this class overall. Most of the time I, and the students around me, were unsure what we were talking about and how it related to our potential degrees. Going through the simulations has been nothing but a confusing ordeal. I honestly feel like this three hour credit was wasted in this class. I have no greater understanding of what it is I'm doing nor how this applies to my Financial Management degree. I do feel that Dr. Burton is a good teacher and an incredibly intelligent and experienced resource from the employment world but I feel that it doesn't translate well into this class. If there were course objectives in this class then I can say with 100% certainty that I, as a student, did not reach them.
- She truly cared about her students and helping them learn! Sometimes, I feel like we worked on things and were tested over

different things. There were occasional times that I felt like what we were doing did not apply. Overall, I think Professor Burton would do anything she could to make this class as valuable as she could, and I appreciate that.

- She is one of the sweetest teachers i have ever had, but her teaching isn't very good at times. Hard to understand and gets off track. She did explain whatever we were learning about to you have you went and talked to her or even email her. Very hard teacher

 understood the material large in part because we were left to our own to learn it. This class would be much better as an online
 course due to our need to learn the material on our own anyways.
- Dr. Burton is not the best communicator. Students will ask questions and never receive a clear response. The EPR system that we are working with is also very confusing. I feel like the whole simulation has been a train wreck. No one seems to know what they are doing and the instructions do not help. I believe that this simulation should be a class by itself. The way to teach or introduce it is not in 15-30 minute sessions, which is what is being done now. It is to complex to only work with in short amounts of time. What would be really helpful is to find video instructions and samples.
- Quite possibly the worst professor I have had while at ACU and i'm a graduating senior. Class is confusing and wanders all over
 the place. I never know what we are doing. The simulation was a main part of the class and it was highly confusing. She didn't
 really give us much help on the simulation. Occasionally rude and blames the students for things they didn't even know about. She
 tries but fails at teaching this class. I also have never given a bad review for a professor so me writing this definitely means
 something.
- Dr. Burton is not an adequate communicator. She does not explain material well. Every test given in this course resulted in a scramble to teach ourselves the material that she claimed to have taught. Everything I have leaned in this course has been taught by my peers or myself. I have spent far more time in a state of confusion and frustration in this course than I did actually learning material. I would recommend that my fellow students take a course at another university before they take anything taught by Dr. Burton.

At first, I thought this was a simple communication issue. However, I have felt personally mislead by her tendency to leave out important information and abide by the rule "it's not wrong to give the wrong idea as long as I don't actually tell a lie." It was frustrating feeling like we had to aggressively probe her in order to simply receive information that was crucial to our success.
