This is a request under the Texas Open Records Act, chapter 552 of the Government Code (formerly V.T.C.S. article 6252) as well as Article I, Sec. 8 of the Texas Constitution, the First Amendment to the United States Constitution, the common law of the State of Texas and any statue providing for public access to government information:

We request that we be sent copies of the following documents or, if there are a large number, be permitted to inspect the following documents and receive copies of the ones we would like:

All information related to reference case number 10-016427 or any other cases related to calls to the Abilene Christian University campus, which is bounded by Judge Ely, Ambler, Campus Court and East North 16th, on Wednesday, Aug. 25. Included in this request are any police reports, witness statements or evidence logs.

If you determine that all or some portion of the information requested is excepted from required disclosure, we request that you provide us with the portions of the requested information that are public and reasonably segregable from that which you believe is excepted. If you determine certain portions of documents contain information that is exempted from disclosure, we respectfully request that information be redacted from the copies and explanation provided for each redaction. If any records are in active use or in storage, please certify this fact in writing and set a date and hour within a reasonable time when the records will be available, as required by section 552.221 of the Act.

If you determine that all or some portion of the information requested is excepted from required public disclosure under a particular exception, we request that you advise us as to which exceptions you believe apply. If you rely on previous determination, please advise us of the applicable court decision or Attorney General's opinion. If there is no such determination, please advise us of the request for such an opinion, as required under section 552.301 of the Act, and a dated copy of your letter to the Attorney General. We call

your attention to section 522.353 of the Act, which provides penalties for a failure to release public records.

We are prepared to pay reasonable costs for copying, within the guidelines set by sections 552.261, 552.262, 552.263, 552.267, 552.268, 552.269.
