Master's programs must include a minimum of 30 hours, and doctoral programs must include a minimum of 30 hours beyond the master's.

⁴ When a department/school or dean proposes closing a program, approval routing follows the typical process beginning with the department/school. An administrative proposal by the provost or senior vice president for academic affairs would follow the "provost-proposed" routing on the chart.

BIOL 101 - Course Outcomes

Catalog description:

BIOL 101 - Biology - Human Perspective

Lecture Hours: 3

Lab Hours: 0

Credit Hours: 3

Terms Offered: Fall, Spring, Summer

A conceptual investigation of biological principles from the human perspective - including historical, theoretical, ethical, and practical aspects. May be used to satisfy Science University Requirements. For non-biology majors. Same as B100 101.

Course outcomes found on old syllabi that may or may not have been approved by council:

Course competencies include demonstrated knowledge and understanding of human biology at the 1) DNA and cellular level, 2) genetic level, 3) systems level, and 4) how humans interact with the rest of the world.

Revised course outcomes:

At the end of this course, a student will be able to:

1. Explain the fundamental biological concepts that relate to the unity of life and understand the goals and limitations of scientific inquiry.
2. Identify the underlying mechanisms of DNA and its relationship to genes, cells, organ systems, and organisms.
3. Understand genetics and its impact on the survival and adaptation of species.
4. Describe mechanisms and misconceptions of evolution.
5. Discuss the interdependence of living organisms within ecosystems and the environment, the ethical implications of human impact, and the sustainable practices to mitigate negative effects.
