2. Adjust for changes in SITC common courses:
 - Delete CS 111 (This will remove 1 hour from the major. Because this major already has more than 128 hours, we are choosing to not add the ITC 110 intro course on top of existing requirements.)
 - Replace CS 495 with the new ITC 460 capstone
3. Add CS 320 Database Programming and Design to the menu of advanced CS electives.
4. Delete PHYS 379 because it no longer meets the gen ed requirements and would increase total hours.
