We would like to close these middle school certifications. The high school certifications now include 7th grade through 12th. Because of a mismatch between state certification structure and federal law, the middle school 4-8 certification only qualifies a candidate to teach 7th and 8th grade unless they add a generalist credential. The testing policies for the generalist credential have changed making the addition of one of these credentials very difficult. Therefore, the 4-8 middle school certification is too limiting for our candidates. They are simply not employable.

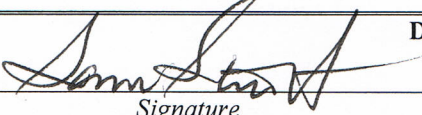

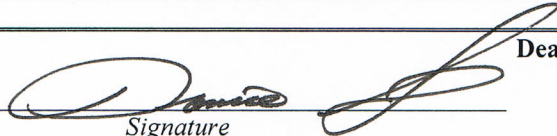

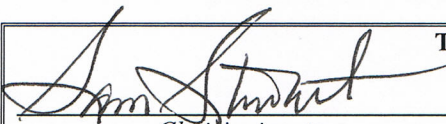
