[We would like to do a retroactive catalog change for the IDSC degree plans. The UUAC passed a request to reduce the degree plan to 128 by reducing the elective hours to 4. We would like the reduction of hours to apply to following catalog years.

13/14 – reduce electives from 5 to 4 taking the degree from 129 to 128.

12/13 – reduce the elective hours from 6 to 4 taking the degree from 130 to 128.

11/12 – reduce the elective hours from 6 to 2 taking the degree from 132 to 128.

This will avoid submission of waivers and will work well with the new degree audit system.]

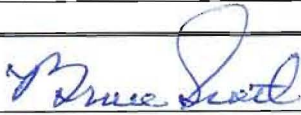

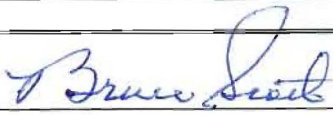
