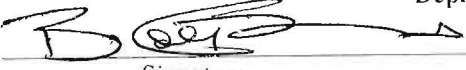

Supporting Disciplines Requirements

Proposal

Drop all the required courses in supporting disciplines for the Spanish Major.

Rationale

In addition to Spanish courses, the major currently requires:

| 2. ENGL 231 World Literature I | 3 credits |
| 3. ENGL 232 World Literature II | 3 credits |
| 4. POLS 227 Introduction to International Relations | 3 credits |

Of these four courses, three may fulfill university requirements (BMIS 371, ENGL 231 and POLS 227).

These will be dropped from the Spanish major for the following reasons:

1. The supporting disciplines place an undue burden on the Spanish major, especially in cases of a second major.
2. In many cases, supporting discipline requirements are *necessary* — even foundational — for advanced study in some fields: math for sciences, biology for medicine, etc. This is not the case for these courses. While these courses may be *nice*, they are not *necessary*.
3. In many cases, students who have satisfied university requirements with other courses (either because they are double majors or because they are switching from another major) are having these requirements waived.

Students will continue to be guided through advising into satisfying university requirements with courses that examine the respective areas from a multicultural or international perspective, but will not be required to satisfy the university requirement again if they have fulfilled it with a different course.
