Course Number KINE 475 and 498 or Degree Plan(s) B.S. in Kinesiology, KNHP, KNOT, and KNPT concentrations

These are catalog changes:

- Change the graduation GPA for the KNPT concentration from 3.0 to 3.2.
- Change the graduation GPA for the KNOT concentration from 2.75 to 3.2.
- Remove the admittance criteria for the KNHP concentration which states: "A minimum GPA of 2.5 is required for acceptance into the KNHP degree track."
- Revise the second and third sentences of the seventh paragraph of the Introduction of the Kinesiology and Nutrition section of the catalog which states: "Kinesiology majors meet this requirement by taking PEAC 100, 206, one of PEAC 211, 214, 215, 216, or 226. Transfers must take KINE 100 at ACU if they have not already completed three exercise science (physical education) activity courses or have completed a course that is determined to be enough like the one at ACU."

The revised text should state: "Kinesiology majors must take KINE 100 and 206, and a PEAC or PEACs as specified in the degree plans. Kinesiology transfers must take KINE 100 at ACU if they have not already completed a course that is determined to be enough like the one at ACU."

- Remove KINE 473 Clinical Exercise Physiology I as a prerequisite for KINE 475 Physical Activity and Aging.
- Remove "summer" from the description of KINE 498 Biomechanics.

These changes are needed so that the catalog aligns with current practice.
