[The English department presented a proposal to the Teacher Education Council last spring to close the IDSH High School English Language Arts degree, which is advised in Teacher Education. There is another degree (ENGT) advised in the English department that leads to the same high school certification. The primary difference in the two degrees is that the IDSH degree plan does not include the foreign language required in the ENGT degree plan. The council was unanimously in favor of this proposal. I have included a letter from Dr. Cole Bennet as additional support for the proposal.]

Dear Committee:

I would like to recommend that ACU discontinue its Bachelor of Science—IDHS (ELA track) degree program. In essence, this degree intends to prepare students to teach high-school Language Arts, but its BS label eliminates all foreign language requirements as a matter of course. The practical consequence of its availability in the ACU catalog is that students who wish to teach classroom English, but who also wish to avoid the foreign language proficiency requirement, are often choosing to pursue this major over the Bachelor of Arts ENGT degree, which prepares students to teach grades seven through twelve and includes foreign language.

I and my colleagues do not feel that any primary teacher of Language Arts will be sufficiently prepared via a university degree absent foreign language study. Hence, we wish the BA ENGT to be the only choice available for such students who wish to teach grades seven through twelve, and we recommend closure of the BS IDHS (ELA) degree program.
