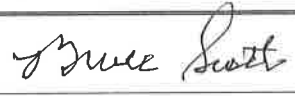

Add EDUC 335 Teaching in Middle School to the degree plan.

Rationale:

We have determined that the Middle School course is critical for these candidates. Recent changes in the federal designation of highly qualified have provided more flexibility in the 4-8 certification, allowing us to streamline generalist content that is outside of the primary teaching field.

These candidates will likely teach in only their primary content field or in a partially departmentalized elementary setting with a social studies and English language arts combination. Therefore, to make room for this three-hour course, we are going to reduce the current science requirement.

Currently, the degree plan includes the following science menu with one course each in biology, chemistry and physical science. We propose reducing that to allow the students to choose two courses.

Current requirements:

- BIOL 101 Biology and Human Perspective or BIOL 203 Basic Biology for Teachers
- CHEM 203 General Science for Elementary Teachers
- PHYS Physical Science for Teachers

Proposed new science requirement:

Choose two from the following:

- BIOL 203 Basic Biology for Teachers
- CHEM 203 General Science for Elementary Teachers
- PHYS Physical Science for Teachers

We chose to remove BIOL 101 from this menu to ensure that students are taking the most relevant science courses for the elementary context and to ensure that they have lab experiences in all science courses. The three courses in the new menu all include lab experiences. It is important to note that CHEM 203 was recently approved to fulfill university requirements in science.
