We are altering this degree plan in order to add course requirements and/or menu options that emphasize public history and memory – replacing HIST 496 with recently-approved HIST 201 and adding HIST 250 as an option in our menu of 100-299 requirements. These courses will prove useful to future teachers as they exemplify a broader range of pedagogies and hands-on learning that these students will be likely to employ in future careers.

And we are adding a few recently-approved HIST courses to our upper-level requirement categories (US, European, non-Western). **All proposed changes are highlighted below in yellow.**

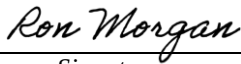

First, y'all, I apologize for not being cognizant of these "standards" issues when I proposed these changes. By the way, as we've created new courses over past few years, and added them to menus and degree plans, I don't know that we've run them by Dana for ""certification standards."

So yes, I've requested syllabi for both 201 and 250, as well as 334.

The first two deal with specific content from post-Civil War US, but in ways that deviate from your standard historical overview of the main national storyline(s). 334 compares cultures and ideas about gender and sexuality from the US, Britain, and India — hence our inclusion of it on all 3 area menus.

So I'll forward these syllabi to Dana ASAP; if we need to revise what we passed through John's council last week, let's catch that now.

As Dana wrote, "after any changes to degrees that include certification go through the college council, they must go through the Teacher Ed Council." Is that suppose to be the first step, or AFTER councils? Because we put those courses into degree plans to send to councils without ourselves knowing the "certification standards" — we don't know the target.

Yes, Dana, I understand your concerns — and not being ideological.

How does anyone in any dept. manage "Topics in" courses? I understand these are not rare. In our case, each course will be taught with particular content and focus. This spring, Tracy is teaching it (still under a 340 number) with focus on African-America; students will receive US credit for that; in fall she'll teach in Oxford with focus on British Empire (Europe); next Spring of 22, I'm doing Mexico, and so on.

I'm not sure how that works in DegreeWorks — above my pay grade.

But CAS council expressed no concerns with the Special Topics course proposal, and passed it.

Take a look at the 334 syllabus; if you and your council decide (and we can agree) that 334 nor 310 concept can work for satisfying the state auditors, maybe we remove all of those from the Social Studies and History Teacher degree plans. But that presents challenges of course availability for those majors, because if I'm teaching Mexico as a 310 course, rather than 490, teacher students could not take it for credit. Unless we teach each of these courses with a dual number (310/490) and enroll students in one or the other based on their degree plans. But I'm sure John and Jessica would tell me reasons why we can't do that.

I did some digging through UUAC past meetings. I am very excited about these changes. The new 201 course provides a pedagogically meaningful course for our majors focused on American History. I was at first concerned that they might take neither 221 or 221 with the choice for 250. I no longer have that concern. These courses will benefit our students in content AND in pedagogy. They will be challenged to think about history in new ways. That is very exciting!

One correction that needs to take place is in the degree plan for HSST, the **designation for the Non-Western description for 310 is not included**. It is important to include that in the degree plan. With that correction, I am ready to provide my support.

Have these changes already gone through CAS Council? If not, when will that take place? I need to schedule the Teacher Ed Council meeting as soon as possible after that so we can move on to UUAC>
