The Department of Communication Sciences and Disorders wishes to change the undergraduate degree plan (COMP) to add CSD 226 Phonetics Lab and a menu of experiential learning requirements to the plan. Students will complete seven hours of coursework with a CSD designation which is already a degree plan requirement and then choose an additional three hours from a menu of EL coursework.

Rationale: CSD 226 addresses a gap of knowledge with phonological awareness and its connection with phonetics. It is believed to assist in reducing the amount of current tutoring that is necessary without a required lab course. The new EL requirement provides additional opportunities to help the student connect classroom learning with clinical experiences, making the students better prepared for graduate school or becoming a speech-language pathology assistant (SLPA).

³ All courses that meet University Requirements for general education must go through UGEC. Courses or degrees offered only to students seeking teacher certification must go through the Teacher Education Council. All undergraduate changes must go before the UUAC. All graduate degree plan changes must go through the Graduate Council.

⁴ A minimum of 30 hours is required for a major. A maximum is specified for each degree (e.g., BA, BS). The university minimum for elective hours is 6, unless the requirements of external accrediting bodies make it impossible.

⁵ Program or course changes that apply to any major that includes Teacher Certification will be reviewed by the college, the Teacher Education Council (TEC), and then the UUAC.

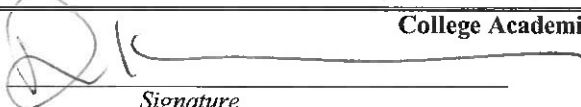
