We would like to change the prerequisites for ART 495 so that it can serve as a capstone course for our new BS degree in Art Therapy and to reflect the success of other degree plan changes enacted in 2014 that ensure student readiness for this course. ART 495 was developed as a course before we changed our fine art degrees from BFA Two-Dimensional Studio or Three-Dimensional Studio to a BFA with a concentration in Painting or Sculpture. Its prerequisites were formed under the old degree plans. Those prerequisites were: "Senior standing and one of ART 318, ART 433, ART 443, ART 463, ART 473, or ART 490 in drawing." We want to change to "Senior standing."

All Fine Art Program students (BFA with a Concentration in Painting or Sculpture) regularly complete one of the menu of courses listed above and those advanced courses are irrelevant to students pursuing an Art Therapy degree.

Additionally, this course was recently moved from being a spring-only course to a fall-only course. We request that information in the catalog be changed as well.

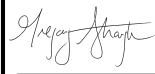
¹ When an academic unit does not have a council, the UGEC and/or UUAC will serve as its academic council, depending on the nature of the issue.
