Change: Modify pre-reqs to fit new BBA degree requirements.

CURRENT: Prerequisite: ACCT 210; ECON 260, ECON 261, with a grade of "C" or better; MATH 130.

PROPOSED: Prerequisite: ACCT 210 with a grade of "C" or better; ECON 260 or ECON 261 with a grade of "C" or better; MATH 130.

Reason: BBA students (other than FIN/FINA majors) no longer must take both ECON 260 and ECON 261. This change allows students to enroll in FIN 310 after completing their ECON requirement. (Ideally FIN/FINA majors will still take both of their required ECON courses before FIN 310, but this is not necessary since many non-FINA majors will only take one ECON course before FIN 310.)

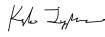

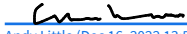
¹ When an academic unit does not have a council, the UGEC and/or UUAC will serve as its academic council, depending on the nature of the issue.
