Texas Administrative Code (TAC) requires that admission to a teacher certification program in Texas include an assessment of basic reading, writing and mathematics skills. In the past we have used the ACT or SAT to fulfill this requirement. If a student did not have an ACT or SAT score or if their scores did not meet the established criteria, we used their final grades in university required mathematics and freshman English courses. Until recently, this was a very small number of students. We have learned that current interpretation of TAC excludes the course grades as a measure. As ACU has moved to ACT and SAT optional admission, we are required by state policy to use an approved assessment for admission to the Teacher Education Program.

Many Texas university teacher preparation programs are now using the TSAI2, an assessment developed through the Texas Success Initiative to determine if non-exempt students are ready for college coursework. If students at public universities in Texas do not meet exemption requirements through one of the official readiness benchmarks (SAT, ACT, College Preparatory Courses, etc.), they must take the TSAI2. This assessment is readily available at a cost of \$29.00 and is approved to fulfill the TAC educator preparation admission requirement. The Teacher Education Program has arranged for vouchers for the exam to be provided by Cisco Junior College. Students will be able to use their vouchers on campus at our testing center.

Admission for admission to Teacher Education will be a minimum score of 945 on the English, Language Arts and Reading section, a 950 on the Math, and an essay score of 5 or better.
