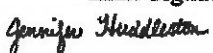

² Any change to a cross-listed course requires the signature of both department chairs or program directors overseeing the course to ensure that the courses stay in sync. This includes courses taught at other campuses (e.g. BIBL 101 and BIBO 101).

³ For undergraduate majors, a minimum of 30 hours is required. These programs must have a minimum of 6 elective hours, unless the requirements of external accrediting bodies make it impossible. Master's programs must include a minimum of 30 hours, and doctoral programs must include a minimum of 30 hours beyond the master's.

⁴ When a department/school or dean proposes closing a program, approval routing follows the typical process beginning with the department/school. An administrative proposal by the provost or senior vice president for academic affairs would follow the "provost-proposed" routing on the chart.

Due to consistent, but light enrollment. It will be most efficient to offer Range and Wildland Plants during odd years (e.g. 2023, 2025...) instead of offering the course every fall as is the previous practice.

In conjunction with this change, we believe that a change in the course prerequisites can and should be implemented in order to allow student to access the course earlier in their degree plans.

- Current Prerequisites:
BIOL 121/BIOL 122 and BIOL 123/BIOL 124 with a minimum grade of "C" and either BIOL 351 or junior standing.
- Proposed Prerequisites:
BIOL 121/BIOL 122 and BIOL 123/BIOL 124 with a minimum grade of "C" **OR** ANSC 111 & ENVR 112.
