Course Number: HIST 329 or Degree Plan(s):

Add ENGL 112 as Prerequisite for HIST 329 (African American History from African Origins to the U.S. Civil War & Reconstruction), a new course approved in Fall 2023.

The prerequisite of ENGL 112 is intended only to ensure that students in the class are prepared for academic writing (e.g., primarily to aid students and advisors in sequencing.) HIST 329 is intended for students of any major who are seeking to understand the past experiences of African descended/Black people in North America and provides relevant historical context for complex present-day issues such as antiblack racial discrimination and recent social justice protests. These topics are relevant and indeed critical to forming students, regardless of major or vocation, for Christian service and leadership in our present environment.

³ For undergraduate majors, a minimum of 30 hours is required. These programs must have a minimum of 6 elective hours, unless the requirements of external accrediting bodies make it impossible. Master's programs must include a minimum of 30 hours, and doctoral programs must include a minimum of 30 hours beyond the master's.

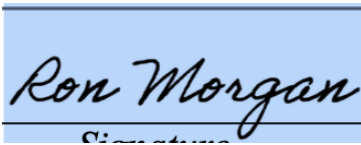
