Request Regarding **BIBM 434 Spiritual Formation of Children**

Request course number change: BIBM 434 to BIBM 334

From a sequencing standpoint, the content taught through this course is foundational for the Children & Family Ministry track of the Bachelor of Arts in Ministry & Vocation degree and therefore needs to be the starting point for this track. Doing so will provide students with a deeper understanding of the subsequent courses and, as a result, support the development of a more effective minister.

Course Description:

This course is designed to equip adults to foster the spiritual formation of children in the many contexts in which they live. Attention will be given to the unique design of each child and how to nurture children toward full participation in the Kingdom of God.

Course Outcomes:

1. Develop a biblical and theological framework for the spiritual formation of children that considers the importance of intergenerational and multicultural relationships.
2. Identify various elements of children's spiritual formation and recognize their appropriate developmental capacities.
3. Discover the importance of spiritual discipline for the individual, family, and church.
4. Recognize the central role of story and ritual in the spiritual formation of faith.
5. Explore the impact of the community of faith on the lives of children and how churches might more effectively meet their needs.
6. Integrate the materials from this course into practical Christian service for children.
