Rationale: With the dispersion of curriculum elements traditionally covered in ENGR 430 to other courses within the curriculum (ENGR 217, ENGR 317, ENGR 390), the classroom time for the course can be reduced to allow for more focused, project related work. Reduces total hours devoted to the major design experience in all engineering degree plans from 6 to 4.

Updated Course Outcomes

1. Establish an acceptable scope for an assigned project
2. Establish requirements and constraints for an Engineering Design Problem
3. Generate evaluate potential solutions to an open-ended Engineering Design problem
4. Evaluate generated solutions against requirements and constraints to select a solution
5. Test selected solutions to verify satisfaction of requirements and constraints
6. Work effectively in a group working on an open-ended Engineering Design problem
7. Communicate Engineering Design work effectively to a variety of audiences

³ For undergraduate majors, a minimum of 30 hours is required. These programs must have a minimum of 6 elective hours, unless the requirements of external accrediting bodies make it impossible. Master's programs must include a minimum of 30 hours, and doctoral programs must include a minimum of 30 hours beyond the master's.

⁴ When a department/school or dean proposes closing a program, approval routing follows the typical process beginning with the department/school. An administrative proposal by the provost or senior vice president for academic affairs would follow the "provost-proposed" routing on the chart.
