We are requesting the removal of KINE 473 as a prerequisite for KINE 485.

Current: This course is designed to advance the application of theoretical and practical guidelines of pre-exercise screening, exercise assessment, exercise interpretation, and exercise prescription.

Prerequisite: At least Junior standing, [KINE 372](#), [KINE 373](#), [KINE 473](#).

Proposed: This course is designed to advance the application of theoretical and practical guidelines of pre-exercise screening, exercise assessment, exercise interpretation, and exercise prescription.

Prerequisite: At least Junior standing, [KINE 372](#), [KINE 373](#).

Rationale: Years ago, KINE 473 was Clinical Exercise Physiology 1, and KINE 485 was Clinical Exercise Physiology 2. About three years ago, KINE 473 was changed to Cardiovascular Physiology, and KINE 485 was changed to Clinical Exercise Physiology (dropping the 2). However the prerequisite of KINE 473 was not removed. Content of both courses has been examined and it has been determined that students do not need the content of KINE 473 in order to be successful in KINE 485. Only the content in KINE 372/373 is a necessary foundation to be successful in KINE 485. Therefore we would like to remove KINE 473 as a prerequisite for KINE 485.

³ For undergraduate majors, a minimum of 30 hours is required. These programs must have a minimum of 6 elective hours, unless the requirements of external accrediting bodies make it impossible. Master's programs must include a minimum of 30 hours, and doctoral programs must include a minimum of 30 hours beyond the master's.

⁴ When a department/school or dean proposes closing a program, approval routing follows the typical process beginning with the department/school. An administrative proposal by the provost or senior vice president for academic affairs would follow the "provost-proposed" routing on the chart.
