Faculty in the Management Sciences department have been teaching MGMT 423 - Social Enterprise Consulting for the past six years. During the last AACSB accreditation cycle, the College of Business developed a Societal Impact Plan and societal impact has become one of the pillars of the COBA strategic plan. As we increase our emphasis on societal impact, we anticipate expanding both the scope of our consulting projects and the number of faculty participating in this course. Because we expect future iterations of this course to include projects from a variety of business disciplines, we would like to change the prefix of the course from MGMT to BUSA. This would be consistent with the course number for our international business class which is BUSA 419. In addition, this would allow us to use faculty from all of the business disciplines so that we can appropriately match the faculty for each iteration with the consulting project(s) assigned to that particular instance of the course.

³ For undergraduate majors, a minimum of 30 hours is required. These programs must have a minimum of 6 elective hours, unless the requirements of external accrediting bodies make it impossible. Master's programs must include a minimum of 30 hours, and doctoral programs must include a minimum of 30 hours beyond the master's.

⁴ When a department/school or dean proposes closing a program, approval routing follows the typical process beginning with the department/school. An administrative proposal by the provost or senior vice president for academic affairs would follow the "provost-proposed" routing on the chart.
