Course Number: BUSA 319 **or Degree Plan(s):**

There are two objectives for this proposal:

1. Change the course code for BUSA 419 to 319.
2. Change the catalog description for the course.

Rationale:

1. Students frequently take International Business prior to their senior year, particularly if they take it in conjunction with a study abroad trip. Many of the students who take International Business on a study abroad trip are sophomores, and signing up for a 400-level course as a part of a study abroad trip can be intimidating for these students and, possibly, a deterrent to participation in the study abroad trip. In addition, the concepts included in this course are compatible with the knowledge that sophomores or juniors bring to the course. There is no reason that International Business needs to be a 400-level course.
2. This course has a significant emphasis on culture and is included in the cultural literacy menu. The current course description, however, does not reflect the large role that the topic of culture contributes to the course content. The new catalog description is included below:

***New catalog description:** This course explores global business operations, focusing on cultural awareness and challenges faced by companies internationally. It covers local customs, laws, and economic factors, teaching students how to adapt business strategies, marketing, and management across cultures, preparing them for careers in the global business environment.*

² Any change to a cross-listed course requires the signature of both department chairs or program directors overseeing the course to ensure that the courses stay in sync. This includes courses taught at other campuses (e.g. BIBL 101 and BIBO 101).

³ For undergraduate majors, a minimum of 30 hours is required. These programs must have a minimum of 6 elective hours, unless the requirements of external accrediting bodies make it impossible. Master's programs must include a minimum of 30 hours, and doctoral programs must include a minimum of 30 hours beyond the master's.

⁴ When a department/school or dean proposes closing a program, approval routing follows the typical process beginning with the department/school. An administrative proposal by the provost or senior vice president for academic affairs would follow the "provost-proposed" routing on the chart.
