Course Number: MGMT 439 or Degree Plan(s):

We currently have many students who arrive with a significant number of hours (e.g. dual credit, advanced placement, transfer credit). This frequently results in students graduating in less than four years and it compresses the timeline in which they take upper-level COBA courses. In a review of the MGMT 439 prereqs, it has been determined that the IS 324/ACCT 324 prereq is a roadblock to student progress through our degrees. In addition, students can be successful in MGMT 439 without having previously completed IS324/ACC324. Therefore, this restrictive prereq should be dropped from the requirements.

In addition, since it is the capstone class, students need to be proficient in Excel prior to taking MGMT 439. Therefore, excel certification is being added as a prerequisite. The language will match what is in the catalog currently for IS 222 and IT 263.

The new prereq language for the catalog is shown below.

Catalog verbiage:

Prerequisite: FIN 310, MGMT 330, MKTG 320 all with a grade of “C” or better and successful completion of COBA Excel certification test or documentation of previously completed equivalent test.

² Any change to a cross-listed course requires the signature of both department chairs or program directors overseeing the course to ensure that the courses stay in sync. This includes courses taught at other campuses (e.g. BIBL 101 and BIBO 101).

³ For undergraduate majors, a minimum of 30 hours is required. These programs must have a minimum of 6 elective hours, unless the requirements of external accrediting bodies make it impossible. Master's programs must include a minimum of 30 hours, and doctoral programs must include a minimum of 30 hours beyond the master's.

⁴ When a department/school or dean proposes closing a program, approval routing follows the typical process beginning with the department/school. An administrative proposal by the provost or senior vice president for academic affairs would follow the "provost-proposed" routing on the chart.
