Course Number: MKTG 319 or Degree Plan(s):

Objective for this proposal:

Change the course code for MKTG 419 to MKTG 319.

Rationale:

We have proposed to change the course number of International Business from BUSA 419 to BUSA 319 for the following reasons

- Students frequently take International Business prior to their senior year, particularly if they take it in conjunction with a study abroad trip. Many of the students who take International Business on a study abroad trip are sophomores, and signing up for a 400-level course as a part of a study abroad trip can be intimidating for these students and, possibly, a deterrent to participation in the study abroad trip.
- The concepts included in this course are compatible with the knowledge that sophomores or juniors bring to the course.

If BUSA 419 is changed to BUSA 319, it makes sense to do the same with International Marketing. Both of these classes fulfill COBA's international requirements and they are targeted at the same level of students. We want to make our offerings as consistent as possible.

³ For undergraduate majors, a minimum of 30 hours is required. These programs must have a minimum of 6 elective hours, unless the requirements of external accrediting bodies make it impossible. Master's programs must include a minimum of 30 hours, and doctoral programs must include a minimum of 30 hours beyond the master's.

⁴ When a department/school or dean proposes closing a program, approval routing follows the typical process beginning with the department/school. An administrative proposal by the provost or senior vice president for academic affairs would follow the "provost-proposed" routing on the chart.
