“ACCT 210; ECON 260 with a grade of “C” or better; MATH 130.”

Reasoning: We are dropping ECON 261, Principles of Microeconomics, as a prerequisite for FIN 311. Money and Banking relies heavily on the concepts of Macroeconomics (ECON 260), and this prerequisite is still valid, but the concepts of *Microeconomics* have little bearing on Money and Banking. By removing ECON 261 as a prerequisite, we are able to help students move through their studies more efficiently without sacrificing their ability to succeed in the class. This would also open up the class to other students who have no requirement for 6 hours of economics, but who need or desire an upper-level business course.

³ For undergraduate majors, a minimum of 30 hours is required. These programs must have a minimum of 6 elective hours, unless the requirements of external accrediting bodies make it impossible. Master's programs must include a minimum of 30 hours, and doctoral programs must include a minimum of 30 hours beyond the master's.

⁴ When a department/school or dean proposes closing a program, approval routing follows the typical process beginning with the department/school. An administrative proposal by the provost or senior vice president for academic affairs would follow the "provost-proposed" routing on the chart.
