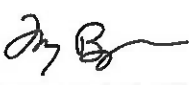
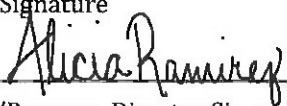
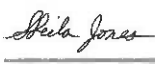

³ For undergraduate majors, a minimum of 30 hours is required. These programs must have a minimum of 6 elective hours, unless the requirements of external accrediting bodies make it impossible. Master's programs must include a minimum of 30 hours, and doctoral programs must include a minimum of 30 hours beyond the master's.

⁴ When a department/school or dean proposes closing a program, approval routing follows the typical process beginning with the department/school. An administrative proposal by the provost or senior vice president for academic affairs would follow the "provost-proposed" routing on the chart.

Rationale for Changes:

This course description represents the original course language and is redundant. The motor speech disorders related to cleft palate, and cerebral palsy continue to be taught in the course, but it is unnecessary to indicate these two diagnoses in the description.
