We would like to move FAM 335 Therapeutic Play from the fall to the spring. This course is on the Child Life Track and has historically taught by adjuncts or faculty the a background in marriage and family therapy. Ideally, this course would be taught by a Child Life Specialist (CLS). Currently, we employ one CLS adjunct, who teaches FAM 325 Child Life in the fall; FAM 325 must be taught by a CLS. Although there are two other CLSs in Abilene, neither are interested in teaching. If we move FAM 335 to the spring, then our current CLS is able to teach both FAM 325 and FAM 335. Advising does not believe this will adversely affect student schedules or degree completion.

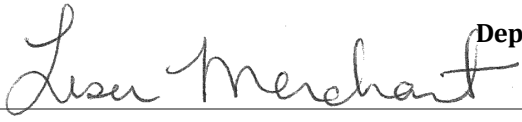
² Any change to a cross-listed course requires the signature of both department chairs or program directors overseeing the course to ensure that the courses stay in sync. This includes courses taught at other campuses (e.g. BIBL 101 and BIBO 101).

³ For undergraduate majors, a minimum of 30 hours is required. These programs must have a minimum of 6 elective hours, unless the requirements of external accrediting bodies make it impossible. Master's programs

must include a minimum of 30 hours, and doctoral programs must include a minimum of 30 hours beyond the master's.

⁴ When a department/school or dean proposes closing a program, approval routing follows the typical process beginning with the department/school. An administrative proposal by the provost or senior vice president for academic affairs would follow the "provost-proposed" routing on the chart.

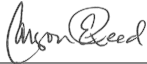
