Current prerequisite: ACCT 210 with a grade of “C” or better; ECON 260 or ECON 261 with a grade of “C” or better; MATH 130.

New prerequisite: ACCT 210 with a grade of “C” or better; ECON 260 or ECON 261 with a grade of “C” or better; MATH 130, *MATW 130, MATH 131, or MATH 185.*

MATW 130 is listed as equivalent to MATH 130 in the catalog entry for MATH 130. With regard to including MATH 131 and MATH 185 as acceptable prerequisites, students who pass Calculus for Application or Calculus I are adequately prepared from a math perspective to take business classes that require MATH 130.

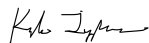
² Any change to a cross-listed course requires the signature of both department chairs or program directors overseeing the course to ensure that the courses stay in sync. This includes courses taught at other campuses (e.g. BIBL 101 and BIBO 101).

³ For undergraduate majors, a minimum of 30 hours is required. These programs must have a minimum of 6 elective hours, unless the requirements of external accrediting bodies make it impossible. Master's programs must include a minimum of 30 hours, and doctoral programs must include a minimum of 30 hours beyond the master's.

⁴ When a department/school or dean proposes closing a program, approval routing follows the typical process beginning with the department/school. An administrative proposal by the provost or senior vice president for academic affairs would follow the "provost-proposed" routing on the chart.
