Course Number: **IT 263 - Analytics 2: Data Management and Visualization** or Degree Plan(s):

Current prerequisite: IS 222; successful completion of COBA Excel certification test or documentation of previously completed equivalent test.

New prerequisite: IS 222 **or MATH 377 with a grade of "C" or better**; successful completion of COBA Excel certification test or documentation of previously completed equivalent test.

IT 263 will be a required course in the new Statistics & Data Science major in the math department. Students in that degree are required to take MATH 377 - Statistical Methods I. The content in MATH 377 will adequately prepare students to take IT 263. Students working toward a BBA degree are required to make a "C" or better in each business class. The addition of that language in the prerequisite section for IT 263 will ensure that students using MATH 377 as a prereq for IT 263 will also have earned a "C" or better in their statistics course.

³ For undergraduate majors, a minimum of 30 hours is required. These programs must have a minimum of 6 elective hours, unless the requirements of external accrediting bodies make it impossible. Master's programs must include a minimum of 30 hours, and doctoral programs must include a minimum of 30 hours beyond the master's.

⁴ When a department/school or dean proposes closing a program, approval routing follows the typical process beginning with the department/school. An administrative proposal by the provost or senior vice president for academic affairs would follow the "provost-proposed" routing on the chart.
