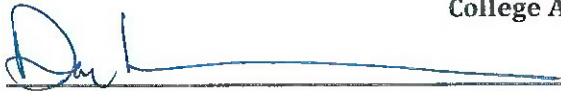

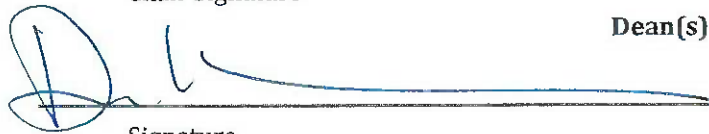

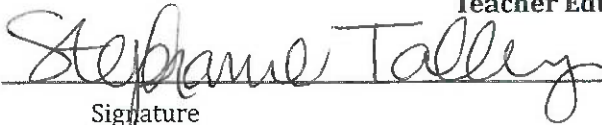

Music Education Degree:

The Texas Education Agency has changed the policy in the Texas Administrative Code for pre-clinical teaching field experiences. This has significantly evolved over the last 15 years or so. In the past, we were only required to report how many hours our teacher candidates completed before clinical teaching. In our TEA Audit 8 years ago, they required that we include descriptions of the reflection assignments along with this report of the number of hours. In our last audit, three years ago, we were required to provide the completed reflection assignments for our teacher candidates. At that time, the number of hours required was 40 and the definition for qualified contexts was much more flexible. The state now requires 50 hours minimum with supervision and structured written reflection.

It is also helpful to have broader context for how secondary and all-levels certification programs often work in other universities and was the structure we used in the past. Often, the certification courses are taken as a minor in education. We decided some time ago that it serves our students better for both advising purposes and the desire to strengthen the partnership between the content field and education to include the certification courses within a certification degree in the content field department.

These changes have presented some challenges, but these challenges are significant and impossible to address without some changes in the Music Education degrees. The particular challenges for these majors are as follows:

- Because of the curriculum demands in the field of music required by their accrediting body, the music education degrees have limited hours available. This is not unique to ACU, but is the challenge faced statewide for teacher certification in music. Because of the curriculum demands of the music accrediting body, we have not included EDUC 412/432, the 6-hour senior block course that now includes the full 50 hours required by the state. We have tried to facilitate these hours in a pieced together fashion in the following contexts:
 - EDUC 449 Professional Practice in Music Education, a 1-hour course to provide the absolute minimum of state required content that these students miss because they have not take
 - Various courses in the music department
 - A modification of the recital requirement for these majors.

These processes are extremely difficult to document appropriately for TEA and there is no load available in the music department for a faculty member to manage this process.

- The new criteria from the state defines field experiences very narrowly. This impacts music more significantly than other teaching fields.
 - In the past, they could count participation with public school performances outside of the school day. This no longer fulfills these required hours. Field experiences must occur during the school day.
 - The new policy also requires that all 50 hours must take place after the teacher candidate is admitted to the certification program. In the past, we were able to count the 8 hours included in EDUC 211 Introduction to Education. However,

admission to the certification program cannot be granted until this course is completed. Therefore, we lost 8 hours from what was previously included.

- All of our students come back early in the fall for the August Experience, participating in preparation with their assigned teacher in the two days before school and observing day one and day two. While we have been doing this for some time, it now fulfills recent requirements in Texas Administrative Code for the required beginning of school observation requirement. Music Education majors almost always complete clinical teaching in the fall. Because these days occurred before the official start date of Clinical Teaching, for several years we had included the 32 hours included in August Experience as part of their required field experiences. In our last TEA audit, we were informed that the policy for these hours had changed and if the placement is in any way connected to Clinical Teaching, it could not count as field hours. Thus, we lost an additional 32 hours.

For these reasons, it is critical that EDUC 412/432 be added to the Music Education degrees. The department has worked to create space for these hours in its MTIA and MTVA degree plans. We reduced two hours in the lower-level music theory sequence, eliminated the one-credit EDUC 449, streamlined the Diction class (for Vocalists), and eliminated the degree elective hours that, while helpful, are less valuable than the experiences available to students in the Education Block. Doing all this work allows the MTIA and MTVA degrees to be 128 hours long, the standard length of an ACU baccalaureate degree.

We are working under greater and greater specificity, reporting requirements and restrictions as we work to prepare our students for certification. It is not possible to continue how the degree and field components are currently structured and fulfill state requirements.

To Whom it May Concern:

I am writing to extend my full support for the changes in program for the music majors pursuing teacher certification. Primarily, the move to include all music majors in our senior level internship courses, allows for the music majors pursuing certification to meet the requirements pertaining to the 50 hours of field experience required by law in order to enter clinical teaching. These hours must be documented for the state. Additionally, students must reflect on their learning in these hours in writing. That documentation must also be saved. Participating in EDUC 411/412 (Elementary or Secondary Curriculum and Media) and EDUC 431/432 (Elementary or Secondary Management in Methods) also allows our music majors to participate in coursework that more fully prepares them in lesson design and planning and classroom management and discipline. This will better prepare them for their futures in public schools. Not only will this help the School of Education better meet the legal requirements of Texas Administrative Code (TAC), it will also better prepare our teacher candidates.
