Rationale: The change to the PSGE aims to provide students with greater flexibility in selecting courses and streamline the advising process, making it more efficient for both students and faculty. The current system results in numerous substitutions and changes as students move through the minor. Further, most students either initially opt for the PSGE General Minor or need to change based on course availability. This slight change removes PSYC 493 off the choices for upper level. That is a writing-intensive course and requires much more breadth and depth than is appropriate for minors.

³ For undergraduate majors, a minimum of 30 hours is required. These programs must have a minimum of 6 elective hours, unless the requirements of external accrediting bodies make it impossible. Master's programs must include a minimum of 30 hours, and doctoral programs must include a minimum of 30 hours beyond the master's.

⁴ When a department/school or dean proposes closing a program, approval routing follows the typical process beginning with the department/school. An administrative proposal by the provost or senior vice president for academic affairs would follow the "provost-proposed" routing on the chart.
