Course Description

This course is a study of advanced techniques in management, assessment, and recognition of athletic injuries specifically related to the upper body.

Purpose and audience

The purpose of the course is to provide study for advanced techniques in assessment of athletic injuries pertaining to the upper body. The course is required for students in the Athletic Training concentration (KNAT) of the B.S. in Kinesiology degree. They must have passed KINE 291 Basic Sports Medicine, KINE 296 Care and Prevention of Athletic Injuries, and KINE 365 Assessment of Injury I.

Format

Power point presentations and live demonstrations will be used to illustrate concepts.

Conduct of the Course/Teaching Methodology

Each class will consist of an hour to hour and one half lecture by me or a guest orthopedic surgery. The second hour and one half will be hands-on demonstration and practical application.

There will be five written exams including the final. Those exams will be fill in the blank (short answer) and multiple choice. There will be five practical exams including the final that will require the student to perform assessments of different injuries and areas of the upper body. We will cover different areas of the body in three to four week increments. Students will be evaluated on their ability to physically examine and assess the status of the injured athlete.

Overview of Content

This course provides comprehensive material concerning aspects of assessment of injury pertaining to the upper body.

The student will be able to correctly assess, recognize, and manage athletic injuries of the upper body.
